While we sorely miss the expertise of so many of our retired faculty, staff and administrators, the work of implementing our college Strategic Plan will be moving forward this year under the leadership of a new faculty co-chair for strategic planning, Kathleen Sell, our Accreditation Liaison, Susan Mills, the chairs of the leadership councils—faculty, staff, student, and a host of new administrators.

## **Highlights & Priorities for 2016-2017**

In May 2016, the Academic Senate approved both the Strategic Plan and the new Constitution and Bylaws so we start this academic year with these in place and ready to continue the work of implementation. The Strategic Planning Website is being updated to ensure that the most recent documents and memberships are available for everyone to consult.

We also start this fall with three new facilities open for business: Coil School for the Arts, the Charles A. Kane one-stop shop for Student Services, and Culinary Arts building. In addition, RCC welcomes to the college several new faculty—many replacement, but also NEW positions allocated through the strategic planning process last year in line with the college's strategic goals. And we have ten new faculty positions to allocate this year, too.

For this academic year, preparing the midterm accreditation report tops the list along with completing the first full round of the new program review process with Divisions presenting integrated division plans to ACTPIS, RDAS, and SAS by the end of September/ early October for review and discussion with actual prioritization to follow in early November. With implementation underway, it is crucial that the college assess its processes, and the IE-LC is crucial here. In addition, staying on track with the schedule of course and program SLOs is essential to continuous improvement. The work of establishing discipline, department, and divisional targets—and the ongoing to work to monitor, assess, and recalibrate these—will also be ongoing as will the work on fully developing and/or revising all the implementation plans
