- [Create an account](#) then 2) Click the link in your email inbox to begin your application. *Check your spam folder if you don't see it.*
- Answer the prompts/questions truthfully and exactly as they are stated.
- For funding request amount enter \$500
- Download your transcript as a pdf - label it as "firstname lastname transcript"
- Have your LinkedIn profile url ready. *Make your profile has YOUR picture*
- Allow yourself at least 30 minutes to complete the application.

**REQUIRED!!! – On the application there is a section where you will type and tell us about your educational journey & plans after completing your program:**

Answer the question as it is written BUT you MUST add at least 2-4 additional sentences using one of the following prompts:

- 1) How can you see yourself utilizing cybersecurity principles in your future career?
- 2) Describe your genuine interest in cybersecurity.

*Use the word "cybersecurity" in your response*

### When should you apply?

**ASAP!** Nothing lasts forever including the remaining funds we have available. If you are eligible, the quicker you submit your application the quicker you can receive your scholarship. Please allow at a minimum of 7-15 business days for us to process your application.

### It's been more than 15+ business days and I don't have an update on my application what should I do?

1. **Check your email spam folder!** Sometimes message end up there.
2. Be patient. During peak season, we receive a high volume of application which means we need extra time to get through them all. All applications are reviewed by a hard working Last Mile team member so please be kind and be patient.
3. Email [studentawards@lastmile-ed.org](mailto:studentawards@lastmile-ed.org) – If you send an email, please include the full name you applied under, your school name, and only email 1 time.

### I checked my spam folder and see that I was awarded this scholarship more than 30+ days ago, can I still accept my award? No, unfortunately you must re-apply.

- *If it has been less than 30 days, you need to follow the next steps in that email immediately.*

### Do you need a specific GPA or letters of recommendation to apply? NO 😊

### Eligibility Requirements

- Currently enrolled in a U.S. community college
- Enrolled in 1 of the following cybersecurity or a related-technology programs
  - Associates
  - Bachelors degree (program is at a community college)
  - Professional certification program
  - Bootcamp
- In-person or virtual, full-time or part-time
- U.S. citizens, international students, and DACA
- All gender identities, all races
- **All applicants MUST have an ITIN (if you are an international student) or a social security number in order to accept your award. No exceptions**

**Our funding opportunities are designed to provide the critical support needed for underrepresented and under-resourced students to cross the finish line – the "last mile" of their educational journey.**

Eligible expenses include, but are not limited to:

- Certification licensing exams
- Tuition support, books, and meal plans
- Conferences registration fees or other outside learning opportunities
- Laptops or technology needed for class
- Career-building opportunities
- Home expenses such as rent, utility bills, groceries, etc
- Unexpected medical bills or car repairs
