• Dr. Farrar's office provided hard copies of the recently updated PCAH for curriculum committee members. All members were thankful for this effort.

## F. Curriculum Policy & Procedure:

- Statewide Curriculum Update
  - Discussion on "local curriculum approval" processes developed by the State Chancellor's Office, and how this will result in further scrutiny at the local curriculum committees.
- Curriculum Institute Update
  - Several curriculum committee members shared their experiences at the recent Curriculum Institute, held at the Riverside Convention Center.
  - The Curriculum Committee expressed its gratitude to both Dr. Isaac and Dr. Farrar for the support in sending faculty, staff, and administrative personnel to the institute.
  - Discussion on continued need for representation at the Institute, regardless of "level" of "expertise" in curriculum.
- PCAH Update
  - As stated above, Dr. Farrar's office provided copies of the updated PCAH adopted by the State Academic Senate.
  - Discussion on the role of the PCAH, Title 5 and education code application to curriculum.
- Statewide ADT Update
  - Dr. Farrar's office encouraged the development of Associates Degree for Transfer (ADT) where appropriate.
  - Currently, there is only one ADT that is *required* to be developed (Film, TV, and Electronic Media).
  - Other disciplines were mentioned as having the potential of developing an ADT.
  - Chemistry, biology and kinesiology may need to be resubmitted for an ADT.
  - Discussion on the process to "add" honors courses into an ADT, where the "non-honors" course currently resides. All ADT's would have to be modified to add these courses (it is not automatic).
- RCCD Curricular Update with State Inventory

- Dr. Farrar discussed the college/districts efforts to reconcile local inventory with statewide inventory. Other issues currently being worked on include a "clean up" of all three college catalogs within the District, especially regarding courses no longer offered.
- TOPS Code Faculty Responsibility
  - One area of concern is within every course outline is an assigned Taxonomy of Programs (TOPS) code.
  - This is a faculty obligation, but historically TOPS codes were input by administrative personnel.
  - Faculty were reminded their responsibility with TOPS code alignment, and were encouraged to double-check TOPS codes for existing courses, and all new courses.

- E. Open Hearing:
  - Questions regarding proposals within META that are "stagnant," or fields that seem to be not available to work on.
  - SLO's vs. Objectives
    - SLO's are an accreditation standard.
    - Course objectives are a Title 5 mandate.

- Course outlines will include both, when appropriate.
- Suggestion this year that all new major mods differentiate between SLO's/Objectives.
- There is no "hard deadline" where courses need this partition.
- Suggestion as courses are updated, partition these two components.
- D. Announcements: No announcements made.
- F. Curriculum Policy & Procedure:
  - Role of faculty, Administration, and Staff in curricular development and consideration.
    - Faculty are responsible for curricular matters, including generation, approval, and ensuring curriculum is current.
    - Administration is fundamentally important in curriculum, especially in regards to bringing to the attention of faculty issues associated with curricular decisions.
    - Support staff ensure that curricular decisions made by faculty are reported and logistically implemented.
  - Cross-listing of courses, and disciplines within a course.
    - There are two types of "cross listing" of courses, which may offer some confusion.
      - A single course "cross-listed" among multiple disciplines.
        - This allows this a single COR to be taught by faculty which meets minimum qualifications for all associated disciplines on the COR.
        - As an example, in HES 1, there are several disciplines which are approved to teach this course. Faculty in those disciplines can all teach HES.
        - This allows a single course to be taught from varying discipline perspectives, which may confer greater diversity and student experience in the course.
        - The course is "housed" with the primary discipline, and it is this primary discipline which can approve additional disciplines. This is often based on the State Minimum Approved Qualifications standards but this is not a requirement.
      - "Cross-Listed Courses" are two courses, associated with different disciplines that are "equivalent" with one another.
        - They have matching COR's, and students can take either course, and receive the same credit towards degree's or certificates.
        - In this case, both disciplines design, develop, and keep current the shared CORs.

- If one COR is proposed to be modified, both disciplines for this crosslisted course need to approve the changes collaboratively. This requires communication between both affected disciplines.
- Any modification to one course must be proposed for the cross-listed course as well, adhering to the curricular approval process.
- Program development and discontinuance.
  - Discussion on the current policies on program development and discontinuance.
  - Program development is an intensive and time-consuming process, that requires thought and effort in its development.
  - Program discontinuance is outlined in policy, and should have the same scrutiny as in program development.
  - The phrase "courses are no longer being offered" is insufficient rationale for a program's discontinuance.

With these new skills, students will be able to obtain entry level employment as a pipe welder's helper or in a shop doing production welds, welding ferrous pipe.

- E. Open Hearing:
  - Printed Catalogs: Kelly Douglas expressed her appreciation for her copy of the printed catalog, which was followed by other faculty on the curriculum committee expressing their thanks as well.
  - AB705 (<u>https://leginfo.legislature.ca.gov/faces/billTextClient.xhtml?bill\_id=201720180AB705</u>).
    - $\circ$  Discussion the passage of AB 705, and its possible impact on local curriculum.
    - Within a week, the state should be releasing guiding principles for local colleges to follow, in order to achieve goals stated in the assembly bill.

- These policies will be enacted by Fall 2019.
- From the above website, language of the bill includes:
  - Requiring community colleges or districts to maximize the probability that the student will enter and complete transfer-level coursework in English and mathematics within a one-year timeframe.
  - Use in the placement of students into English and mathematics courses in order to achieve this goal, one or more of the following: high school coursework, high school grades, and high school grade point average.
  - Establishes regulations governing the use of measures, instruments, and placement models to ensure that these measures, instruments, and placement models achieve the goal of maximizing the probability that a student will enter and complete transfer-level coursework in English and mathematics within a one-year timeframe, and that a student enrolled in English-as-a-second-language (ESL) instruction will enter and complete degree and transfer requirements in English within a timeframe of 3 years.
  - Prohibits a community college district or college from requiring students to enroll in remedial English or mathematics coursework that lengthens their time to complete a degree unless placement research that includes consideration of high school grade point average and coursework shows that those students are highly unlikely to succeed in transfer-level coursework in English and mathematics.

### PROPOSED CODING FOR NEW CERTIFICATE PATTERN: 0508.00

### RATIONALE FOR NEW CERTIFICATE PATTERN:

To promote independent economic opportunities in a stackable locally approved mini-certificate that can lead to a concentration or Associate of Science Degree in International Business.

The intention of this International Business Mini-Certificate is to replace the currently existing International Business Locally Approved Certificate, which we have been offering successfully for the last few years. The rationale for the replacements are: (1) The currently existing certificate is not stackable since it includes courses outside of the discipline. This new mini-certificate is composed of only existing courses in the discipline, all of which counts towards the Associates of Science Degree in International Business; (2) This Mini-Certificate is comprised of only the courses that are specifically focusing on international business subject matter. The currently existing Locally Approved Certificate include course from other disciplines which may be relevant to international business, but not directly related to the subject matter.

### SHORT DESCRIPTION OF PROGRAM

This program prepares individuals to be able to understand how international business operates and to prepare individuals in professions in international business realm.

### CERTIFICATE PROGRAM LEARNING OUTCOMES

- Explain the key elements of international business. Analyze the essential factors that determine the success of each element of international business.
- Explain the inter-relationship of each elements of international business that are required for a successful international business operation, and the criteria needed to manage a successful international business operation.
- Develop the framework of an international business plan, incorporating understanding of general business concepts, international marketing mix, international management theories and practices, international cultures, international economics, and international politics.

    - Re-emphasis of curriculum submissions being complete, which will alleviate delays in approval:
      - Attached files must include discipline and department discussion and approval.
      - Attached files for issues like transfer institutions.
      - Curriculum submission author coordination with:
        - Discipline facilitator approvals.
        - Department chair approvals.
        - Technical review for requested changes.
      - Once curriculum reaches technical review, any known issues at that point will be addressed with proposal author and discipline.
    - Program submission paperwork and approval trail.
