**F. Curriculum Policy & Procedure:**

- Steven Schmidt (Curriculum and META transfer update):
  - META is in final beta testing.
    - There will be one more “refresh” with CurricUNET prior to its launch.
  - When META is ready to be launched, CurricUNET will be shut down for a few days, during the transition.
    - During this time, all existing curriculum on META will be erased, and replaced with existing curriculum on CurricUNET.
  - Currently:
    - CurricUNET is active. All curricular activities can be conducted through CN.
    - META can be viewed at any time, and has outlines and existing proposals available.
    - All materials on META can be “practiced with,” however, nothing that is done on META currently will remain as changes. All changes in META (currently) will be erased during the final transition.
      - This gives faculty a chance to work with the META version of CurricUNET, without fear of harming any curriculum.
    - When CurricUNET is “frozen” all activity will be transferred to META, and at that time only META can be used to modify or create curriculum.

- A. Chair Burchett called the meeting to order at 3pm.
- B. The **agenda** was approved (Vermillion/Schmidt/Unanimous).
- C. The **minutes** of September 13, 2016 were approved (Vermillion/Boshara/Unanimous/2 abstentions) with minor corrections.
- E. **Open Hearing:**
- One of our student guests expressed concern over courses offered during college hour. She stated that there are students who would like to become more involved in campus student activities, but because they are enrolled during courses offered at that time, they are unable to participate. The committee thanked her for her concern, and the chair stated that he would raise these concerns at the Academic Senate on their behalf.

## F. Curriculum Policy & Procedure:

- Update on residency:
  - The chair updated the committee on the issue of “residency” within the District, as a follow-up to this committee’s work on this subject in the Spring 2016 semester.
  - The District Academic Senate tasked the Academic Standards Committee on developing possible changes to the residency policy. Standards recommended lowering residency from 15 to 12 units. Both Moreno Valley and Norco AS have voted to reduce residency. Riverside has not voted on this issue as of yet.
  - According to what the chair was told by the President of the Norco Senate (and District AS chair during the 2015-16 school year), reasons behind this reduction in units centered on, what was believed to be, statute requirements for this 12-unit limit (in both AB1440 and Title 5 Section 55063). Based on these arguments, both Moreno Valley and Norco AS have voted to reduce residency to 12 units.
  - Chair noted that curriculum had tackled these issues in-depth last school year, and at no time was the CC consulted by the AS or by Academic Standards.
  - Chair expressed concerns regarding the lack of communication between all three groups.
  - Chair expressed concerns regarding the perceived mandates – if MV/N Senate’s voted to reduce residency were based on the argument that statute forbid 15-units, then logically our policy needed to be modified to 12 units. However, chair noted that nowhere within AB 1440 is residency addressed, and Title 5 Section 55063 (below) sets the *mimimum* units of residency at 12:
    - *“The required 60 semester or 90 quarter units of course work must be fulfilled in a curriculum accepted toward the degree by a college within the district (as shown in its catalog). It must include at least 18 semester or 27 quarter units in general education and at least 18 semester or 27 quarter units in a major or area of emphasis as prescribed in this section. Of the total required units, at least 12 semester or 18 quarter units must be completed in residence at the college granting the degree. Exceptions to residence requirements for the associate degree may be made by the governing board when it determines that an injustice or undue hardship would be placed on the student.”*
  - Chair expressed concerns regarding this topic based on perceived mandate requirements, which in fact do not exist.
  - Chair noted the need for continued communication, and will update the Riverside CC.
- META migration timeline:
  - Steven Schmidt updated the CC on the timeline for the META migration.
    - This calendar week, CurricUNET “New Proposal” and “Launch” features will be disabled. This will prevent any new curricular activity from being initiated.
    - Thus far, data migration into META looks good, and will continue through the weekend.

- On the “course proposal side” of META, everything looks good at this point.
  - On the “DE proposal side” of META, there are still some minor changes needed, but these can be done within META without causing further delay in META going “live” next week.
    - Steven gave a handout to the CC members, for consideration to possible changes within META and our DE proposals.
  - META is scheduled to go “live” on Tuesday, October 4, 2016.
    - After this point, CurricuNET will no longer be functional.
    - After this point, the “sandbox” version of META will still be able to be used as a training tool, as in its current state.
  
- Biology 20
  - Chair introduced the course BIO 20 for discussion on its designation of “extensive preparation” laboratories. Prior to any motion, questions were fielded and discussion ensued regarding the “general idea” of what differing contractually defined lab designations were, how they are outlined in the Faculty Contract, and what the process is for approval.
  - During the discussions, the CC asked the Biology department for documentation on its recommendation, and a brief explanation on the proposed lab designation.
  - Chair noted that this course will be placed on the next agenda for action.
  
- CTE COR Review Cycle
  - The topic of the two-year requirement for CTE programs to update curriculum was brought up, and discussed on a superficial level.
  - Several faculty expressed the desire to streamline the process.
  - Note:
    - After the meeting, the chair received several emails regarding the wishes to streamline this process.
    - As a reminder, CTE programs are required to review not only their programs every two years, but also to make sure that the course outlines are updated as well. There is no requirement that outlines must be modified every two years. The only expectation is that the discipline faculty regularly examine whether their COR’s satisfy the needs of the CTE programs. If the COR’s don’t need any changes (minor or major modifications), then there is no requirement that the COR’s must be modified.

  - In META, one observation was that “course comparison reports” were not readily available, for committee members. Chair noted that this will be addressed, in order to make this important tool available.
  - Committee members noted that on META, “active” course outlines of record were not available for public access. Chair noted that this issue has been raised at the District Curriculum Committee, and is currently being addressed.



- Note: Having current COR's is a legal mandate which the District is obliged to provide to the general public. Currently, active COR's are available on the older version of CurricUNET. There will be search features placed onto the welcome page for META.
- Discussion on the importance of Course Content and Student Learning Outcomes.
  - Course content is the basis of the course outline. Discussion on content topics and sub-topics, and the need for both defined content as well as flexibility for teaching the courses.
  - Student Learning Outcomes is the basis for course and program assessment, where course content/methods of instruction and evaluation all form the basis of student course assessment, as part of overall course assessment.
- Discussion on the process to propose honors courses, which include discipline discussion with the Honors Advisory Counsel and course proposal justification.
- On many course outlines within META, there are messages referring to "server error application" and "runtime" issues.

- A. Chair Burchett called the meeting to order at 305 pm.
- B. The **agenda** was approved with minor corrections (Phelps/Romero/Unanimous).
- C. The **minutes** of March 14, 2017 were approved (Romero/Phelps/Unanimous).
- E. **Open Hearing:**
  - Phelps expressed concerns about lab manual inputs in META, which currently require a specified date. This causes problems in entering lab manuals. Schmidt will work with Governet on input methods.
- D. **Announcements:**
  - Curriculum Institute
    - Chair reminded the committee of the institute on July 12 to 15, 2017.
    - This year the institute is being held at the Riverside Convention Center.
    - Chair asked for anyone interested in attending to let him know.

- When the President's office decides on how many faculty it will sponsor, chair will share this information with the committee.

**F. Curriculum Policy & Procedure:**

- State changes to CID approval and impact on programs.
  - Discussion on recent memo regarding changes in approval timeline policy.
- Attachment of minutes within META.
  - Beginning in Fall, all proposals will require attached documentation of minutes for discipline and department.
  - This has always been a requirement, but not strictly enforced.
  - Reminder that discipline and department faculty are recommended to look over curriculum in META, but this is not a requirement.
- Update of new faculty, as well as faculty retirement or reclassification.
  - The employment and access record of META is being updated, with new administrative and faculty positions being updated within META.
  - Reminder to keep notifying curriculum on changes, to keep META access current.
- Curriculum Webpage update.
  - Chair has requested a designated webpage, on the RCC website, be created for curriculum.
  - This was done in hopes of easy access to faculty, staff, and the general public.
  - Chair asked committee for suggestions on website content possibilities.
- Update on program change proposals (from floor):
  - The committee asked for an update on the English proposal for inclusion of REA courses in the GE pathway.
    - Chair expressed concerns raised last week on GE program modification proposals at the Technical Review Committee.
    - Current proposal was put on hold for further discussion.
  - The committee asked for an update on the Biology proposal to change the Math & Science AOE, as well as proposed "clean up" language to GE patterns as a result of its proposed curricular proposals.
    - The BIO proposals were put on hold at Technical Review for further discussion.
  - This update, and the proposals on hold at technical review, led to further discussion of the curriculum committee:
    - There seems to be some confusion to language on differing pathways, regarding degree patterns which has become increasingly evident in different committee discussions.

- GE
  - This is the general education pathway, that every student must fulfill to receive a degree at RCC.
- ADT
  - These are additional major options at RCC, and include occupational AA/AS degrees.
- AOE
  - These are “majors” and areas of concentration, within general educational degree programs.
- One concern raised at Technical Review is that there was an agreed upon “moratorium” on GE change submissions several years ago.
  - This committee expressed its concern that it was unaware of this moratorium.
    - This moratorium has led to several disciplines who would like to apply for GE approval, waiting on submissions on GE changes. This interpretation of the moratorium was the largest concern raised at TR.
    - If proposed changes are allowed to progress, all faculty should have had the opportunity.
  - This moratorium was questioned if, in fact, it existed. The GE pathway has, in fact, changed with District Curriculum Committee approval:
    - As an example of the GE pathway and definition within the District changing recently, the GE degree pattern requirements were drastically changed District-wide.
      - The existing Area’s A-D plus “additional” degree requirements were recently changed to Area’s A-E.
      - Health Science 1 was removed as a requirement in Area’s A, B, and C, and changed to an option. It remains a requirement in Area E.
    - An example of a discipline with courses which were recently added to the GE list of options, Early Childhood Studies had courses which were added to GE applicable courses within the GE pathway.
- One concern raised at Technical Review was the proposal form for changes to the GE, AOE, and ADT programs.
  - These proposed changes to the forms were voted on by the Riverside Curriculum Committee, and submitted to the District Curriculum Committee in the Fall of 2016 for consideration.

- Discussion whether this was a change in the District approval process, or a simple change to the form itself.
- The proposal submitted by Riverside City CC was a change in the format of the form itself, not to the approval process in any way.
- One concern raised by curriculum committee members is on the timing of proposals which was currently agreed upon.
  - The curriculum committee agreed upon February 27, 2017, as the deadline for written submission to Technical Review for consideration.
  - The English discipline submitted their proposal prior to the agreed upon deadline, on the existing forms (not the proposed forms).
  - If this proposal is not allowed to move forward, English expressed its concern for following the process that was understood from its perspective, and how this decision would impact its program in the 2017/2018 academic year.
- Once concern raised by the committee is on communication (or the lack thereof) for all faculty.
  - The submission date proposed by the Riverside Curriculum Committee was shared with Technical Review and the District Curriculum Committee.
  - Whether this proposed deadline was accepted or not, any timeline for submission should be conveyed to all faculty, through curriculum committee representation at departments.
- Due to concerns raised during this discussion, chair asked for written clarification of concerns from committee membership prior to next week’s technical review and District curriculum committee meetings. The committee charged the chair with:
  - The English proposal of REA 4 in GE inclusion, and status for inclusion to the 2017/2018 catalog.
  - The Biology proposal to AOE changes in Math & Science, and status to the inclusion of the 2017/2018 catalog.
  - Clarification of all pattern approval definitions, processes, and timelines for submissions in the Fall 2017 or Spring 2018.

Notes:

1. If changes are requested for the proposal, the deadlines show the timeframe to get changes completed. This needs to be done by the course author.
2. This refers to "STOP" levels, where the proposal is prevented from moving forward. There are only three places where this will happen. (1) at the course author stage (i.e. if the proposal isn't "launched" into Curri-cUNET), (2) at the discipline level, and (3) at the department level.
3. All proposals launched are "frozen" and cannot be touched again by the course author. Also, make sure that discipline and department minutes are attached to the course proposal.
4. If a proposal is for one college, but the district discipline facilitator is at another college, it is the responsibility for the course author to ensure that the discipline facilitator moves the course forward. Any conflicts should be brought to the attention of the Technical Review Committee as soon as possible.

5. If the course proposal is for one college, then only that particular college department chair needs to approve. If the proposal is for a course at more than one college, then all affected department chairs must “push” proposal forward. Any conflicts should be brought to the attention of the Technical Review Committee as soon as possible.
6. Administrative review cannot hold up any proposal.
7. At technical review, the curriculum committee or district curriculum committee levels, course proposals can be stopped, but there is no official “hold” – the course proposal is only held up while requested changes are done.
8. Technical review tries its best to ensure the quality of submissions to the curriculum committees for consideration.
9. The curriculum committees are the first place where a course proposal is voted upon.
10. There are two types of proposals looked at by the District curriculum Committee. (1) Informational items, that are located at only one college, and (2) action items, where the District Curriculum Committee votes on the proposal, based on the results of the affected college curriculum committees. At the District Curriculum Committee level is where conflicts between colleges are also settled.
11. These levels are out of any control of the curricular approval process, once submitted.
