## 7. Reports

- a. Curriculum Chair Kelly Douglass
  - i. Possible review and discussion of ADT/AOE Council proposal deferred to some time in May
  - ii. Added report item: AB 1111 update:
    - 1. Please note for all disciplines, there is nothing you need to do, or can do, yet *locally*, but know that we did get a memo on this in April. There are statewide meetings happening in June we can participate in (see below).
    - 2. The state Chancellor's Office has a three-phase plan; phase 1, so far, will involve six specific courses that are supposed to be revised and launched in fall 24 for fall 25. We will have more info on the scope when we get info over the summer and in August.
    - 3. The courses don't even have the numbers agreed to yet or the named new four-character designations, or the required course elements, but we know what they are by their description:

These courses will improve transfer and articulation for approximately 1 million students. The Phase I cluster of courses will inform processes, templates, and professional development needed for complete implementation. Throughout spring and summer 2024, as a part of a collaboration between the Chancellor's Office and the ASCCC, faculty from the California Community Colleges, CSU and UC will convene to define the common elements necessary for the first set of cohort classes with an eye toward improving articulation processes and maintaining the autonomy of the local curricular needs for all three segments.

- 4. So clearly this will involve English, Communications, Math, Political Science, and Psychology; because of the change to a four-character discipline name abbreviation instead of our current three-character abbreviations, it will also not just be these courses
  - a. Faculty will have to go through a regular major modification proposal for the above six courses to address any changes with required elements.
  - b. The rest of the discipline, all courses in the discipline, will also have to change to be that new abbreviation as well. This will happen clerically through our curriculum specialists and will not involve faculty.
- 5. We don't know at this time how courses that have the same C-ID as the courses listed above may be or if they will be impacted by this round of changes.
- 6. More info immediately upon return in the Fall for our local curriculum process; in the meantime, Dr. Wright mentioned the following to be on the look out from ASCCC (or from Dr. Wright or Chair Douglass who may receive a forward); from ASCCC Communications: "The CCC Chancellor's Office determined August 15, 2024 as the date by which CCN descriptors for the initial 6 courses shall be finalized to meet their proposed timeline. Because of this, the ASCCC will be convening intersegmental discipline meetings on June 12, June 18, and June 24. These meetings will be held virtually, across multiple dates in June to accommodate the differing faculty schedules across the

state. The ASCCC will provide a stipend for participants with funding provided by the CCC Chancellor's Office. An invitation to register will be sent out soon. Prior to the meetings, the ASCCC will distribute a survey for each of the courses to gather intersegmental discipline faculty feedback in order to help shape the outcomes of the June convenings. Once the June convenings are complete, the ASCCC will call on a smaller group of faculty to work on finalizing the CCN descriptors by the August 15 deadline."

- iii. Reminder about cross-listing vs. cross-discipline
  - 1. Cross-listing are identical courses the sections are offered on the same time. CORs must match exactly. Each discipline can schedule the course (the coordination is a good idea).
  - 2. Cross Discipline course is in one discipline and they have oversight/ownership. However, someone in another discipline with appropriate FSA could teach the course if that discipline is added as a cross-discipline.
  - 3. Discussion of possible examples for consolidation like CIS/CSC/CAT as well as new discipline of Public Health. Program created in Nursing, but could be taught by BIO or KIN faculty with a health FSA. Kelly will look at Public Health specifically to make sure set up as intended.
- iv. Meeting time update
  - 1. This was raised a few years ago and discussed at the October 26, 2021 meeting; at that time, there was a consensus to keep the meetings 3-5.
  - 2. Discussion ensued on the option to move meetings to 2:30-4:30; most faculty didn't feel too strongly either way, but would prefer the 30 minute earlier time to address traffic.
  - 3. Representatives asked to think about it, consult with departments and possible future reps, to return to as an action item in May.
- v. Representative election update inquiry see roster above; send Douglass updates as you have them
- vi. Curriculum Institute interest inquiry
  - 1. If you want to go reach out to Dr. Wright
  - 2. It is in Pasadena, July 10-13 or 11-13 if you don't go to the pre-session
- b. Articulation Officer Ellen Drinkwater
  - i. AB928 had many changes in it, including mandatory placement on the ADT pathway with the following exceptions
    - 1. an ADT pathway does not exist in the chosen major at the college
    - 2. the student's educational pathway is better served by a local associate degree
    - 3. the student plans to apply to transfer to a UC campus or an independent college or university
    - 4. the student is seeking to complete a community college baccalaureate degree program

- 5. the student is seeking to complete a career technical education program that does not have an ADT pathway.
- ii. The mandatory placement will begin Summer 2024.
- iii. Discussion of various questions:
  - 1. Does the student know they are being placed? Students will select where they will be placed.
  - 2. How hard will it be for a student to change their major? They will do it through counseling.
  - 3. If there is a local degree and ADT which will the student be placed on? This is still being figured out.
  - 4. Existing students will not be impacted.
- c. Instructional Programs Support Coordinator Casandra Greene
  - i. Compliance Reports
    - 1. Reports will be out this week.
    - 2. Faculty who only need a minor modification (changes only to items below content area) will go to the board for board dates, which will make keeping classes compliant, especially CTE that require 2-year review, easier.
  - ii. Catalog
    - 1. New catalog is live online and has many student-friendly features including course summaries that popup when the cursor hovers over the name in a program, etc.
    - 2. Check out and let Casandra know if there are any concerns or anything that looks incorrect.

  - i. AB1111 and AB928 as covered earlier in meeting
  - ii. Dr. Wright thanked Casandra for her hard work on this project and praised her for the ingenuity and precision in getting it done.

  - b. From ASCCC: Disciplines List
    - i. In February, the annual process for formally reviewing the Disciplines List, which establishes the minimum qualifications for the faculty of California community colleges, was initiated.
    - ii. ASCCC is currently accepting proposals to revise the Disciplines List for the 2024-2025 cycle. The deadline for submission of proposals is September 30, 2024. Proposals received after the deadline may be held for the 2025-2026 cycle.
    - iii. ASCCC sent out an email with resource materials to help you with the process and requested that this be provided to, among other college folks, curriculum committee members, who should provide this to their department chairs – I will forward the email for you to share as warranted.
  - c. FYI: CalGETC future impact on textbook section of COR discussion of reiterated and new policies more on this when operational.
    - i. OER are acceptable if they are constant and publicly available as published textbooks i.e. not a list of links (already true)
    - ii. Textbooks must be identified in the CCC Course Outline of Record and published within seven years of the course submission date or clearly identified as a classic on the COR.
    - iii. Lab science courses must have a clearly identified Lab manual included in the COR
