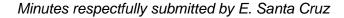

RCCD's Distance Education Conference:

The Changing Face of Online Learning: New Technology and the OER Movement Friday, 20 April 2018 – Digital Library Auditorium – 8am-4:30pm

Report by Steve Brewster for RCC Library Department

- During our meeting I'll pass around the Conference Folder that includes the Conference Schedule and the brochure with short biographical information about the Conference Presenters.
- RCCD's Distance Education [Open Campus] Director Rolando Regino moderated the conference throughout the day.
- Chancellor Isaac welcomed the conference, speaking 15 minutes or so about:
 - The importance of each California community college's continuing to improve its distance education program –
 - O With this especially so because of the Governor's push for a "California Online Community College" another effort, along with the California Virtual Campus (see: https://cvc.edu) of the California Community Colleges Chancellor's Office Online Education Initiative (see:) see:

- OPENING PLENARY SESSION 8:50-10:15 (see agenda for the six speakers) Main takeaways:
 - o Interesting and encouraging to hear from these quite knowledgeable leaders in distance education at their respective sister California community colleges
 - Especially their efforts to inform faculty, seek greater buy-in from them, and provide various kinds of ongoing training for faculty toward improving their distance education offerings.
 - Fresno City College [FCC]: Jodie Steeley, Director of Distance Education & Instructional Technology, highlighted points of FCC Distance Education progress and success over the past two years – with, for example:
 - Of the 30,000 students/16,000 FTE at FCC, 26% of these taking distance education courses, and the DE course success rate is 4% greater than the average success rate for online courses in California community colleges [per this "success rate" see http://www.ppic.org/press-release/online-courses-in-community-colleges-see-major-growth-but-student-success-rates-lag/ although it's dated September 2014].
 - FCC Distance Education's extensive/intensive faculty AND student training in how to do, how to take online courses, etc.

 - Reedley College: Amanda Traintor, Faculty Coordinator, Instructional Design and Distance Education (but wears other hats too!), at Reedley College (one of the State Center Community College District colleges along with Fresno City College and Clovis Community College, then the Madera Community College Center and Oakhurst Community College Center) highlighted the enormous benefit OERs has been to Reedley College students given that 30% of the population in the Reedley College service area is below the poverty level [per the U.S. Department of Health and Human Services, an annual income of \$24,600 or less for a family of four),

with 80% of the Reedley students classified as "low income students" – and in other ways enthused about OERs, for example:

- Defined as "now cost, open license" educational materials, modules, software and with the invitation to: Take It, Use It, Modify It!
- Benefits: For Students Offers Affordability & Access; For Faculty Invigorates Pedagogy; For A College: Improves Student Support and Success (persistence, etc.).
- UCR: Sheryl Hathaway, Associate Director, Academic Engagement Information Technology Solutions, highlighted UCR's extensive/intensive faculty training efforts as well, and not only related to online teaching/distance education, but conventional course pedagogical methods and approaches as well.

- Notable too: Several of the colleges represented by these six speakers have full-time or nearly full-time "online course designers" to help faculty deliver the curricular, course content for which faculty are responsible in the most appealing and effective ways online.

Guided Pathways from Tonya Huff

Here is a short summary of info from the most recent Guided Pathways meeting:

The first chunk of Pathways funding has been received and much of the meeting was spent discussing how we should distribute that funding during continued implementation of the Pathways program. After hearing about how other schools are handling this process, the consensus seemed to be that RCC needs either a full-time Guided Pathways Coordinator or two half-time Coordinators (depending on willingness of individuals who might take on this job). Additionally, it was concluded that we likely need 4-5 part-time coordinators from the disciplines / clusters to help with implementation. We discussed the idea of combining that responsibility with the already-existing Faculty Advisor Coordinator position so that all of the Pathways concepts are truly integrated into the various programs. We did not come to an official decision but the group seemed to agree on the above plan and Susan Mills will likely continue the discussion with administration.

Many program maps have been received but there are still quite a few that have not and there seems to be some confusion / lack of knowledge across campus about what this "Pathways" idea is and how it will be implemented. Many are apparently viewing it as just another program rather than a real change in the structure and how things are done at RCC. We discussed the fact that we need continued efforts toward education and communication about the program on campus.

Academic clusters have been approved and sent to EPOC for final approval. Some work has begun on creating graphics for each cluster that will eventually be used on the website, on printed materials, etc. We looked at two versions of the graphics and overwhelmingly voted for one version of the designs so Carol was going to move those forward.
